An active chief member shall be entitled to vote on all matters requiring a vote unless otherwise prohibited by the Constitution and By-Laws and shall be entitled to hold elective office. A department with less than 30 emergency responders, the Fire Chief and one (1) Assistant/Deputy Chief will be identified as active members who will have voting rights, all others of that department will be considered to have Departmental Membership.
